#### **ECTS AND GRADING SYSTEM**

The Croatian national grading scale consists of five grades with numerical equivalents:

- 5 = excellent izvrstan (highest grade)
- 4 = very good vrlo dobar
- 3 = good dobar
- 2 = sufficient dovoljan (minimun pass grade)
- 1 = fail nedovoljan

#### Croatian grading system and mapping from ECTS grades

- 5 = excellent izvrstan (highest grade) A
- 4 = very good vrlo dobar B
- 3 = good dobar C
- 2 = sufficient dovoljan (minimun pass grade) D, E
- 1 = fail nedovoljan

#### **ECTS - EUROPEAN CREDIT TRANSFER SYSTEM**

1 ECTS credit is equivalent of approx. 30 working hours. Credits are awarded only when the course has been completed and all required examinations have been successfully taken. 60 ECTS credits represent the workload of a year study, 30 ECTS credits a semester.

#### **E-INDEKS**

Upon enrolment students get their own electronic student transcript book – e-indeks. It contains a list of courses taken, grades awarded and ECTS achieved.

When the student passes the exam the professor will write down the student's grade.

#### TRANSCRIPT OF RECORDS /TRAINEESHIP CERTIFICATE

All incoming students are provided with the Transcript of Records/Traineeship Certificate with full and accurate record of their achievements at the end of their mobility period.

#### STUDENT IDENTITY CARD - THE X CARD

Exchange students are entitled to hold a student identity card, so called the *X Card*. It is a sort of a prepaid card used in students' cafeterias and restaurants. It is not only a "licence to eat", but also a card that proves your student status, so you can get some tickets and services at a reduced price.

#### **VISA, INSURANCE, ACCOMMODATION**

#### **VISA/REGULATION OF STAY**

EU/EEA citizens can enter Croatia with just a valid ID card (or passport) and then need to register at the Central police station if staying for more than 3 months to regulate the residence permit.

Citizens of the USA, Australia, Canada, etc. (for full list see Ministry of Foreign and European Affairs) can enter Croatia with a valid passport and then apply for the residence permit in Zagreb. Check with the

Croatian embassy in your country of residence which documentation you will need for your application in Zagreb and make sure you take it along when coming to Zagreb.

NON-EU/EEA citizens coming from a country that has a visa-regime with the Republic Croatia need to apply for a visa via the Croatian embassy in their home country before departing for Croatia.

Visas CANNOT be applied for or extended in Croatia! Please contact the Croatian embassy in your country of residence for more information.

Students living in the student hall of residence can regulate the permit 30 days after the arrival in Zagreb, students in private accommodation should do it within 3 days upon arrival.

Documents need to be submitted at the Central Police Station in Petrinjska 30, HR-10000 Zagreb.

#### **HEALTH INSURANCE**

All exchange students need to have health insurance during their stay in Croatia. Regulated health insurance is the prerequisite for being granted temporary residence.

All EU/EAA students need to bring their European Health Insurance Card (EHIC) in order to qualify for the services provided by the Croatian Health Service.

The EHIC card must be requested from your home country's health service before you leave. This card will entitle you to free medical assistance, i.e. day hospital care, hospital treatment and prescriptions.

All non-EU/EAA exchange students are required to register for Croatian health insurance upon arrival.

#### **Accident insurance**

Erasmus students are recommended to be supplied with insurance coverage against accidents and liability during their whole stay in Croatia. The policy should also cover any accidents that may occur during educational activities. Insurance cover may be taken out with a private insurance company.

In either case, you should produce evidence of this insurance when enrolling.

#### **ACCOMMODATION**

University of Applied Health Sciences does not guarantee accommodation but will offer assistance in finding suitable accommodation.

#### **Student dormitories**

Students that want to live in a student hall of residence need to apply for accommodation. The housing request form is a part of the general online application form for exchange students.

#### **Private accommodation**

International students will have to organize accommodation on their own, i.e. look for private rental accommodation. Rents vary greatly depending on the location, room size, facility etc. Overhead expenses are sometimes included in the price, and sometimes are paid by the consumer. Payment is usually expected at the beginning of the month, while some landlords request payment for several months in advance. There are two ways to rent a room/flat:

1. Look for/run an advert in a newspaper or in the classified ads (e.g. www.oglasnik.hr and www.njuskalo.hr).

Examples of prices: Single room with shared kitchen and toilet: 100-200 EUR per month; Studio apartment: 300 EUR per month.

#### 2. Youth hostels

If you prefer private accommodation and would like to live in a rented flat, before choosing a nice one, you might want to spend some time in a hostel. <a href="https://www.hostelbookers.com/">https://www.hostelbookers.com/</a>

#### **LIVING EXPENSES**

Average monthly living expenses in Croatia are estimated to be between 400 and 600 EUR depending on the type of accommodation, student needs and lifestyle. These amounts should be enough to cover food, accommodation, utilities, books, transportation and miscellaneous expenses.

#### **WELCOME MEETING**

Welcome meeting will be organized by the International Team with the aim to welcome incoming international students and give them essential information about registration, enrolment to courses and services provided by the University.

#### STUDENTS WITH DISABILITIES

Students with disabilities can contact the Erasmus Coordinator and discuss their special needs and requirements in order to get adequate support during their study at our University.

#### **AFTER YOUR ARRIVAL**

If you are an Erasmus student, you should enrol within <u>2 days of arriving</u> - to do this, hand the following documents to the Erasmus Coordinator:

- copy of the passport or any other identification;
- 2 passport-size photographs;
- your University's certificate testifying to your Erasmus Student status;
- Accident Insurance certificate (valid abroad) if you have any;
- EHIC (European Health Insurance Card) for medical assistance.

The office will issue the student book and and a document certifying your registration.
