ANNOUNCEMENT

For the enrollment of students into **the first year of undergraduate professional study programmes** in the English language in the academic year 2022./2023.:

2. Admission and enrollment criteria into the first year of undergraduate professional studies:

- Completed secondary school education
- Knowledge of the English language at B2 level of the Common European Framework of Reference (CEFR)
- 3. Required documentation:

3.1. Citizens of the Republic of Croatia

- 3.1.1. Originals or certified copies of their secondary school certificates (for all the years of secondary school and the final certificate of education)
- 3.1.2. Original certificate of the medical and psychophysical capabilities to study medicine issued by the physician of general medicine
- 3.1.3. Copy of the identity card
- 3.1.4. English language proficiency certificate at B2 level (Cambridge and Oxford English language exams and certificates issued by (foreign) language schools, as well as certificates of English language proficiency issued by a secondary school the candidate attended (the same does not apply to candidates whose mother tongue is English or who have completed secondary school or study at a higher education institution in English).

3.2. Foreign citizens

3.2.1. Originals or certified copies of their secondary school certificates (for all the years of secondary school and the final certificate of education) with an official transcript of grades or, if secondary school certificates (for all the years of secondary school including the final certificate of education) are originally in English or Croatian, their original and certified copy.

3.2.2. Official document for recognition of foreign qualification

Applicants who obtained their secondary school education abroad must have their secondary school diploma recognized in Croatia in order to be fully enrolled (at Agency for Vocational Education and Training)

- 3.2.3. Original certificate of the medical and psychophysical capabilities to study medicine issued by the physician of general medicine
- 3.2.4. Vaccination card
- 3.2.5. Copy of passport
- 3.2.6. English language proficiency certificate at B2 level (Cambridge and Oxford English language exams and certificates issued by (foreign) language schools, as well as certificates of English language proficiency issued by a secondary school the candidate attended (the same does not apply to candidates whose mother tongue is English or who have completed secondary school or study at a higher education institution in English).

Additional documentation must be submitted by 30 June 2022 at the latest.

4. Entrance exam

Candidates apply for the admission process electronically, through the internal information system of the University.

Interest can be expressed by the following deadlines:

- 1. April 30, 2022 the first deadline
- 2. June 30, 2022 the second deadline

The University of Applied Health Sciences reserves the right to cancel the enrollment process if a sufficient number of candidates do not apply.

5. Tuition

Tuition fee is 3,500 EUR per year (paid in kunas) and can be paid at once or in two instalments.

6. Success in the entrance exam

The ranking list will include the applicants who have submitted all the necessary documentation by June 30, 2022. Applicants will be ranked according to the grade point average of all the years of secondary school and the State Matura grade.
